X-Ray Department The department provides plain film x-rays for 6 sessions a week
(reduced from 10 during the pandemic) and ultrasounds for 6
sessions a week – the department is located in the main hospital
with a separate reception and waiting area. This reduction is

temporary with plans to reopen sessions when staffing allows rather than permanently reducing cover.
Services provided from the hospital As well as the services provided at the hospital, there are a range of community services provided from the hospital - it is also the base for the Health and Social Care Team (H&SC).
The team is accommodated in different areas on the 1st floor, mainly in one large office unit but with some members of the team based in several disparate and cramped offices in a separate part of the hospital away from the main team. Various options have been considered to improve the accommodation to enable staff to work in an integrated and more efficient way; for example refurbishing the void attic space adjacent to the current 1st floor office which would provide sufficient space for all teams to work together.
Devon Partnership Trust and the Axminster Ambulance Service (SWAST) have buildings co-located on the site.
There is a large staff rest room with kitchen facilities on the first floor which requires redecoration. Orders have been placed for new soft furnishings and white goods. NHS PS is to undertake the redecoration.
Our approach to future developments
- We want to provide a variety of clinics and services at our community sites
 We recognise that helping people to travel less and have more services available in their local area is important We want to create opportunities that enable teams and services to work together and improve coordinated services being available to members of the public Working in partnership is important. We are really grateful for what LoFs have funded so far and for the support you continue to give to us
What have we done?
 Prior to 2020, the RDE Surgical Division identified Axminster as the preferred site for an offsite Ophthalmology Hub. The decision was made because

The LOFs highlighted that they do get regular reports of patients having to go to another hospital rather than Axminster. <u>ACTION:</u> <i>Gill George to provide information to Zoe Harris via Dr</i> <i>Phil Taylor.</i>
	It was reported there was a rumour that Axminster Hospital is being sold. Zoe explained that the RD&E doesn't own Axminster Hospital. The property is owned by NHS Property Services and she had definitely not heard this rumour.
	A question was raised regarding the possibility of beds returning to Axminster Hospital as there is an issue with ambulances having to queue. It was felt that if there were more community beds this would free up beds in the RD&E. Dr Phil Taylor replied – No. It is better for the patient to have a short stay in hospital and get home to recuperate.

Over the years we have been able to build up some significant reserves which has enabled us to support the hospital and other community needs. As with all facets of life over the last two years, the pandemic has impacted the League's income significantly. Despite this, we have supported nurse training courses, ophthalmology equipment as well as Hospiscare@home. Across 2020 and 2021 we have supported the community to the tune of £370,000 with income of circa £75,000. In isolation, this doesn't paint a rosy picture but this is why we've built reserves over the years, to allow us the leeway to develop such services such as the end of life home support. We still have reserves in excess of £450,000 but we need to ensure that our income stream is re-energised and boosted so that we can continue to augment the NHS to give the people of Axminster the best possible services.
